Unilever NV and Unilever PLC - Transactions in Own Shares

Unilever NV announces that on 25 October 2005, it purchased 81,352 Unilever NV ordinary shares (in the form of depositary receipts thereof) at prices between EUR57.35 and EUR57.95 per share. The purchased shares will be held as treasury shares.

Following the above purchase and release, Unilever NV together with subsidiary companies, holds 20,978,886 Unilever NV ordinary shares in treasury, and has 550,597,014 Unilever NV ordinary shares in issue (excluding treasury shares).

Unilever PLC announces that on 25 October 2005, it purchased 479,263 Unilever PLC ordinary shares at prices between 560.50 pence and 567.00 pence per share. The purchased shares will be held as treasury shares.

Following the above purchase, Unilever PLC holds 6,744,294 Unilever PLC ordinary shares in treasury, and has 2,904,714,286 Unilever PLC ordinary shares in issue (excluding treasury shares).
