Unilever NV announces that on 16 May 2007 it purchased 900,000 Unilever NV ordinary shares (in the form of depositary receipts thereof) at prices between euro 22.655 and euro 22.733 per share. The purchased shares will be held as treasury shares.

Unilever NV also announces that 90,146 Unilever NV ordinary shares held as treasury shares were released under Employee Share Plans.

Following the above purchase and release, Unilever NV together with subsidiary companies, holds 66,457,318 Unilever NV ordinary shares in treasury, and has 1,648,270,382 Unilever NV ordinary shares in issue (excluding treasury shares).
