Unilever NV also announces that 86,301 Unilever NV ordinary shares held as treasury shares were released under Employee Share Plans.

Following the above purchase and release, Unilever NV together with subsidiary companies, hold 115,456,307 Unilever NV ordinary shares in treasury and has 1,599,271,393 ordinary NV shares in circulation.
