Unilever NV announces that on 11 February 2008 it purchased 1,740,000 Unilever NV ordinary shares (in the form of depository receipts thereof) at prices between euro 20.900 and euro 21.400 per share. The purchased shares will be held as treasury shares.

Unilever NV also announces that 6,492 Unilever NV ordinary shares held as treasury shares were released under Employee Share Plans.

Following the above purchase and release, Unilever NV together with subsidiary companies, holds 123,027,239 Unilever NV ordinary shares in treasury, and has 1,591,700,461 Unilever NV ordinary shares in issue (excluding treasury shares).
