Unilever NV announces that on 19 February 2008 it purchased 1,500,000 Unilever NV ordinary shares (in the form of depositary receipts thereof) at prices between euro 20.650 and euro 21.200 per share. The purchased shares will be held as treasury shares.

Unilever NV also announces that 6,534 Unilever NV ordinary shares held as treasury shares were released under Employee Share Plans.

Following the above purchase and release, Unilever NV together with subsidiary companies, holds 132,639,939 Unilever NV ordinary shares in treasury, and has 1,582,087,761 Unilever NV ordinary shares in issue (excluding treasury shares).
