**ChipMOS RECEIVED APPROVAL TO EXTEND ITS SHANGHAI INVESTMENT  
OBLIGATIONS TO THE END OF 2007**

**Hsinchu, Taiwan, March 23 , 2005** ChipMOS TECHNOLOGIES (Bermuda) LTD.
