ChipMOS REPORTS SEPTEMBER 2005 REVENUE

Hsinchu, Taiwan, October 19, 2005 ChipMOS TECHNOLOGIES (Bermuda) LTD. (ChipMOS or the Company) (Nasdaq: IMOS) today reported its unaudited consolidated revenue for the month of September 2005.

Revenue for the month of September 2005 was NT\$1,343.5 million or US\$40.5 million, an increase of 5% from NT\$1,277.8 million or US\$38.5 million for the month of August 2005 and an increase of 2% from NT\$1,322.0 million or US\$39.8 million for the same period in 2004. (All translations from NT dollars to U.S. dollars were made at the exchange rate of NT\$33.18 against US\$1.00 as of September 30, 2005.)

ChipMOS September 2005 consolidated revenue included revenues of ChipMOS TECHNOLOGIES INC., ChipMOS Japan Inc., ChipMOS U.S.A., Inc., ChipMOS TECHNOLOGIES (H.K.) Limited, ChipMOS Logic TECHNOLOGIES INC., CHANTEK ELECTRONIC CO., LTD., Modern Mind Technology Limited and its wholly-owned subsidiary ChipMOS TECHNOLOGIES (Shanghai) LTD., and ThaiLin Semiconductor Corp.
