On October 18, 2005, Richardson Electronics, Ltd. issued a press release announcing the declaration of a cash dividend. A copy of the press release is furnished below:

Richardson Electronics Announces Second Quarter Dividend

LaFox, IL, Tuesday, October 18, 2005: Richardson Electronics, Ltd. (NASDAQ: RELL) today announced that its Board of Directors voted to declare a cash dividend for the second quarter of fiscal 2006 to all holders of common stock.

The cash dividend of \$0.04 per share will be payable November 25, 2005 to all common stockholders of record November 8, 2005. The Company currently has 14,290,918 shares of common stock outstanding, net of shares held in treasury. A dividend equal to 90 percent of the dividend paid on the common stock will be paid to the holders of the 3,109,697 outstanding shares of Class B common stock.
