**Item 8.01 Other Events.**

On October 19, 2007, DURECT Corporation (the Company) entered into a privately negotiated transaction with a holder of its 6.25% Convertible Subordinated Notes, due June 2008 (the Notes), pursuant to which such holder elected to convert \$1.75 million in principal amount of such Notes into 317,460.3 shares of common stock per \$1,000 principal amount of Notes, for an aggregate of 555,555 shares of common stock, as originally set forth in the indenture for such Notes. The Company made a cash payment to such holder of \$122,500, which amount satisfies the future interest payments due on such Notes until maturity of \$109,375 plus a small premium for early conversion. The Notes and the common stock issuable upon conversion of the Notes were previously registered by the Company under the Securities Act. Following such conversion, the aggregate principal amount of outstanding Notes is \$23.6 million.
