#### Item 8.01 Other Events.

In a press release issued on August 12, 2008, RadioShack Corporation (the Company) announced the pricing of its offering of \$325 million aggregate principal amount of 2.50% convertible senior notes due 2013 through an offering to qualified institutional buyers pursuant to Rule 144A under the Securities Act of 1933, as amended. The aggregate principal amount offered was increased from the previously announced \$300 million amount. In connection with the offering, the Company granted the initial purchasers a 30-day option to purchase up to \$50 million aggregate principal amount of additional notes solely to cover over-allotments, if any. The sale of the notes is expected to close on August 18, 2008, subject to satisfaction of customary closing conditions.
