This Registration Statement on Form S-8 is filed by Marchex, Inc., a Delaware corporation ( *Marchex* or the *Company* ) to register an additional 1,774,752 shares of the *Company*'s Class B common stock, par value \$0.01 per share, issuable under the *Company*'s 2003 Amended and Restated Stock Incentive Plan, as amended (the *Plan* ). This Registration Statement consists of only those items required by General Instruction E to Form S-8.
