On February 8, 2012, in connection with the Issuer's public offering, Mr. Steinhardt sold 2,350,000 shares as a selling stockholder and The Judy and Michael Steinhardt Foundation sold 1,150,000 shares as a selling stockholder. As of February 8, 2012, after giving effect to the public offering, Mr. Steinhardt beneficially owned 31,655,362 shares of the Issuer's common stock.
