(collectively, the H&F Funds) will distribute an aggregate of 8,088,055 shares of the Company's common stock previously owned by them to their respective limited partners. Following the distribution, the H&F Funds will continue to hold an aggregate of 18,872,128 shares of the Company's common stock.
