This Registration Statement on Form S-8 is filed by Marchex, Inc., a Delaware corporation ( "Marchex" or the "Company" ) to register an additional 1,924,511 shares of the Company's Class B common stock, par value \$0.01 per share, issuable under the Company's 2012 Stock Incentive Plan (the "Plan" ). This Registration Statement consists of only those items required by General Instruction E to Form S-8.
