On June 4, 2014, Caesars Entertainment Corporation issued a press release announcing that its subsidiary, Caesars Entertainment Operating Company, Inc. (CEOC), has amended its previously announced cash tender offers for any and all of its 5.625% Senior Notes due 2015 (the 5.625% Notes) and any and all of its 10.00% Second-Priority Senior Secured Notes due 2015 (the 10.00% Notes), subject to financing and other conditions.
