**Item 5.07. Submission of Matters to a Vote of Security Holders.**

Permian Basin Royalty Trust (the Trust ) held a special meeting of its unit holders on Friday, June 20, 2014, at 1:00 p.m. central time at Shady Oaks Country Club, 320 Roaring Springs Road, Fort Worth, Texas 76114 (the Special Meeting ).

At the Special Meeting, unit holders of the Trust were asked to consider and vote upon (i) the appointment of Southwest Bank as successor corporate trustee of the Trust, and (ii) to approve certain other amendments to the Permian Basin Royalty Trust Indenture dated November 3, 1980 (the Indenture ), as more fully described in the definitive proxy statement filed by the Trust with the Securities Exchange Commission on March 31, 2014, as amended.

Of the 46,608,796 units outstanding and entitled to vote as of the record date for the Special Meeting, 24,652,491 units were present at the Special Meeting in person or by proxy. As such, a quorum was established at the Special Meeting.

The proposals voted on by the unit holders at the Special Meeting and the voting results are set forth below.

1. Proposal to approve the appointment of Southwest Bank as successor corporate trustee to serve as trustee of the Trust once the resignation of Bank of America, N.A., the current Trustee of the Trust, takes effect, was approved by the following vote:
