**Item 5.02. Departure of Directors or Certain Officers; Election of Directors; Appointment of Certain Officers; Compensatory Arrangements of Certain Officers.**

On February 5, 2014, the Board of Directors (the Board ) of Actavis plc ( Actavis ) voted to reduce the size of the Board from fourteen to twelve directors effective upon the earlier of the closing (the Closing ) of Actavis acquisition of Allergan, Inc. ( Allergan ) and Actavis 2015 annual general meeting of shareholders (the 2015 Annual Meeting ).

In order to effectuate the reduction in the size of the Board and accommodate the appointment of two members of the Allergan board of directors to the Board at the Closing, as contemplated by the merger agreement entered into by Actavis and Allergan, each of Tamar D. Howson, John A. King, Jiri Michal and Andrew L. Turner will resign from the Board, in each case effective upon the earlier of the Closing and the 2015 Annual Meeting. The selection of the Allergan directors to be appointed to the Board at the Closing is ongoing.

The decision of each of Ms. Howson and Messrs. King, Michal and Turner to resign from the Board was not the result of any disagreement with Actavis on any matter relating to its operations, policies or practices.
