On March 11, 2015, the Federal Reserve announced that, based on qualitative concerns, it objected to the capital plan submitted as part of the Federal Reserve's Comprehensive Capital Analysis Review (CCAR) process by Santander Holdings USA, Inc. (SHUSA), the controlling shareholder of Santander Consumer USA Holdings Inc. (the

Company). Due to the Federal Reserve's objection to SHUSA's capital plan, the Company is prohibited from paying dividends until the Federal Reserve issues a non-objection to a SHUSA capital plan submission. In addition, on September 15, 2014, SHUSA entered into a written agreement with the Federal Reserve memorializing prior discussions under which, among other things, SHUSA is prohibited from allowing its non-wholly-owned nonbank subsidiaries, including the Company, to declare or pay any dividend, or to make any capital distribution, without the prior written approval of the Federal Reserve.
