As of the close of business on March 16, 2015, the record date for the Annual Meeting, 36,732,683 shares of common stock of the Company were outstanding and entitled to vote. 32,435,776 shares, or 88.3% of the outstanding common stock entitled to vote at the Annual Meeting, were represented in person or by proxy.
