On June 24, 2015, Farmers National Banc Corp. (the Company) issued an investor presentation relating to the previously announced Agreement and Plan of Merger (the Merger Agreement) entered into by and among the Company, Tri-State 1<sup>st</sup> Banc, Inc. (Tri-State), and FMNB Merger Subsidiary, LLC, a newly-formed wholly-owned subsidiary of the Company (Merger Sub), providing for, among other things, the merger of Tri-State with and into Merger Sub (the Merger). Farmers intends to utilize the investor presentation during a conference call to be held at 10:00 a.m. ET on June 25, 2015.

A copy of the investor presentation is attached hereto as Exhibit 99.1 and incorporated herein by reference. The investor presentation is furnished herein, as part of this Item 7.01, as Exhibit 99.1. Pursuant to General Instruction B.2 of Current Report on Form 8-K, the information in this Item 7.01 and Exhibit 99.1 shall not be deemed to be filed for purposes of Section 18 of the Securities Exchange Act of 1934, as amended (the Exchange Act), or otherwise subject to the liability of that section. The respective directors and executive officers of the Company and Tri-State and other persons may be deemed to be participants in the solicitation of proxies from shareholders of Tri-State with respect to the proposed Merger.
