EXPLANATORY NOTE

BB&T Corporation (BB&T , the registrant , we or our) hereby amends its Registration Statement on Form S-4 (No. 333-207147) (the Form S-4) by filing this Post-Effective Amendment No. 2 to Form S-4 on Form S-3 (the Form S-3) containing an updated prospectus relating to the offer and sale of 118,000 shares of the registrant 's common stock issuable upon the exercise of certain outstanding option awards held by former employees of National Penn Bancshares, Inc. (National Penn), which merged with and into BB&T effective April 1, 2016 pursuant to the Agreement and Plan of Merger, dated as of August 17, 2015, by and between BB&T and National Penn. These securities were initially registered by the registrant on the Form S-4, which became effective on October 23, 2015. The Form S-3 is being filed to convert 118,000 shares of the registrant 's common stock covered by the Form S-4 to be covered by the Form S-3.

Pursuant to the Agreement and Plan of Merger (the Merger Agreement), dated as of August 17, 2015, by and between BB&T Corporation (BB&T , the registrant , we or our) and National Penn Bancshares, Inc. (National Penn), National Penn merged with and into BB&T, with BB&T as the surviving corporation, on April 1, 2016 (the Merger). Upon completion of the Merger, each option granted by National Penn with respect to National Penn common stock that was outstanding and unexercised immediately prior to the effective time of the Merger was assumed by BB&T and converted into a stock option with respect to shares of BB&T common stock, based on the formula set for in the Merger Agreement and described in the Registration Statement on Form S-4 (No. 333-207147) filed by BB&T (the Form S-4), which became effective on October 23, 2015.

This prospectus relates to the offer and sale of 118,000 shares of BB&T s common stock issuable upon the exercise of certain outstanding option awards held by former employees of National Penn.

Our common stock is listed on the New York Stock Exchange under the symbol BBT. Our principal executive offices are located at 200 West Second Street, Winston-Salem, North Carolina 27101. Our telephone number is (336) 733-2000.

National Penn. Pursuant to the Merger Agreement, National Penn shareholders received, for each share of National Penn common stock, subject to the proration and allocation procedures set forth in the Merger Agreement, either (i) \$13.00 in cash or (ii) 0.3206 shares of BB&T common stock. In addition, we agreed to assume outstanding options with respect to shares of National Penn common stock previously issued by National Penn, including those held by former employees of National Penn.

We will not receive any proceeds from the sale of the shares of our common stock covered by this prospectus other than proceeds from the exercise of the options whose underlying shares of common stock are covered by this prospectus. We have no plans for the application of any of these proceeds other than for general corporate purposes. We have no assurance that any of the options will be exercised.

PLAN OF DISTRIBUTION

We are registering 118,000 shares of our common stock issuable upon the exercise of the options.

Pursuant to the terms of the applicable options, shares of our common stock will be issued to those option holders who elect to exercise and provide payment of the exercise price. We do not know if or when the options will be exercised. We also do not know whether any of the shares of common stock acquired upon exercise of any options will subsequently be resold. We are not using an underwriter in connection with this offering.

LEGAL OPINION

The validity of the shares of BB&T common stock offered hereby has been passed upon for BB&T by Robert J. Johnson, Jr., Senior Executive Vice President, Secretary, General Counsel and Chief Corporate Governance Officer of BB&T. At the time of rendering the legal opinion, Mr. Johnson owned shares of common stock and held restricted stock units and options to purchase additional shares of common stock.

Item 15. Indemnification of Directors and Officers

Sections 55-8-50 through 55-8-58 of the North Carolina Business Corporation Act contain specific provisions relating to indemnification of directors and officers of North Carolina corporations. In general, such sections provide that: (i) a corporation must indemnify a director or officer who is wholly successful in the defense of a proceeding to which he is a party because of his status as such, unless limited by the articles of incorporation and (ii) a corporation may indemnify a director or officer if he is not wholly successful in such defense if it is determined as provided by statute that the director or officer meets a certain standard of conduct, except that when a director or officer is liable to the corporation or is adjudged liable on the basis that personal benefit was improperly received by him, the corporation may not indemnify him. A director or officer of a corporation who is a party to a proceeding may also apply to a court for indemnification, and the court may order indemnification under certain circumstances set forth in the statute. A corporation may, in its articles of incorporation or bylaws or by contract or resolution of the board of directors, provide indemnification in addition to that provided by statute, subject to certain conditions.

BB&T's bylaws provide for the indemnification of any director or officer of the registrant against liabilities and litigation expenses arising out of his status as such, excluding any liabilities or litigation expenses relating to activities that were at the time taken known or believed by such person to be clearly in conflict with the best interest of BB&T.

BB&T's articles of incorporation provide for the elimination of the personal liability of each director of BB&T to the fullest extent permitted by law.

BB&T maintains directors' and officers' liability insurance that, in general, insures: (i) BB&T's directors and officers against loss by reason of any of their wrongful acts and (ii) BB&T against loss arising from claims against the directors and officers by reason of their wrongful acts, all subject to the terms and conditions contained in the policy.

Certain rules of the Federal Deposit Insurance Corporation limit the ability of certain depository institutions, their subsidiaries and their affiliated depository institution holding companies to indemnify affiliated parties, including institution directors. In general, subject to the ability to purchase directors' and officers' liability insurance and to advance professional expenses under certain circumstances, the rules prohibit such institutions from indemnifying a director for certain costs incurred with regard to an administrative or enforcement action commenced by any federal

banking agency that results in a final order or settlement pursuant to which the director is assessed a civil money penalty, removed from office, prohibited from participating in the affairs of an insured depository institution or required to cease and desist from or take an affirmative action described in Section 8(b) of the Federal Deposit Insurance Act (12 U.S.C. § 1818(b)).

In the event that a claim for indemnification against such liabilities (other than the payment by the registrant of expenses incurred or paid by a director, officer or controlling person of the registrant in the successful defense of any action, suit or proceeding) is asserted by such director, officer or controlling person in connection with the securities being registered, the registrant will, unless in the opinion of its counsel the matter has been settled by controlling precedent, submit to a court of appropriate jurisdiction the question whether such indemnification by it is against public policy as expressed in the Act and will be governed by the final adjudication of such issue.
