This filing relates to the proposed acquisition of G&K Services, Inc. ( G&K or G&K Services ) by Cintas Corporation ( Cintas ) pursuant to the terms of the Agreement and Plan of Merger, dated as of August 15, 2016, by and among G&K Services, Cintas and Bravo Merger Sub, Inc.

G&K Services sent a letter to its suppliers on or after August 19, 2016 in respect of the proposed acquisition by Cintas. The following is a copy of that letter:

Dear Valued Supplier,

On Tuesday, August 16, we issued a press release regarding the acquisition of G&K Services by Cintas. This announcement marked the signing of an agreement between the two companies. As is typical, this combination requires regulatory and shareholder approval. As such, this acquisition is not yet complete, and, until it is, G&K and Cintas remain two separate companies. We anticipate completing the transaction in the next four to six months, although it could take longer.

The combination of these two great companies makes sense. Both companies share a long legacy of strong operational and financial performance and maintain a similar set of core values grounded in 1) a strong commitment to customer satisfaction, 2) a focus on safety for our customers employees and our own, and 3) a history of being good corporate citizens, with a focus on environmental stewardship.

I want to take this opportunity to thank you for being a valued supplier to G&K Services. You may be wondering about the implications on our business relationship. Because it is too early to speculate on Cintas future strategy, we must continue to operate our business as usual until more information is available. And, because we are waiting for regulatory approval, we must run our business as if nothing has changed.

At this time, uninterrupted service to our customers remains very important. We depend on you, as a member of our supplier community, to ensure that G&K's customers continue to receive important products and services in a timely manner.
