(1) Includes 10,000 shares for a restricted stock grant. Fifty percent of the grant vests in two years on January 3, 2008, and the balance after four years on January 3, 2010.

(2) Each unit of phantom stock is the economic equivalent of one share of Johnson Controls common stock. The restricted stock units were accrued under the Johnson Controls Restricted Stock Plan. The units represent the reinvestment of dividends and are to be settled 100% in cash upon the vesting of the reporting person's Restricted Stock.

(3) Fifty percent of the options become exercisable two years after the grant date; the remaining 50%, three years after grant date.
