The range of prices for the transactions reported was from \$17.27 to \$17.54. The reporting person undertakes to provide, upon request by the staff of the Securities and Exchange Commission, the issuer or a security holder of the issuer, full information regarding the number of shares purchased at each separate price. Because there was a delay in processing the trades, Mr. Pasquerilla's broker has credited his account with the amount that it believes would have been received if the trades had been executed as instructed. While the weighted average share price shown on the table reflects the prices at which the trades were actually executed, Mr. Pasquerilla's account was credited with \$18.209 per share as a result of this broker adjustment.
