The option purchase price was paid in accordance with the 2002 Plan in the form of 5,441 shares valued in accordance with the 2002 Plan. In addition, 1,686 shares were withheld to pay Federal withholding taxes as permitted by the 2002 Plan and option grant. As a result of the transactions reported on this form, the reporting person's direct ownership of common stock increased by 3,548 shares.
