Includes 11,729 RSUs that may be settled only for shares of common stock. RSUs vest one year after the grant date and, on the settlement (2) date, are convertible into shares of common stock on a one-for-one basis. The settlement date is either three years after the date of grant, for RSUs granted before July 2005, or six months after the reporting person ceases to be a director of Sara Lee, for other RSUs.
