In general, these Ford Stock Units will be converted and distributed to me, without payment, in cash, on January 10th of the year following termination of Board service, based upon the then current market value of a share of Common Stock.

(2) Due to an administrative error, the reporting person's original Form 4 overstated the number of Ford Stock Units acquired by 5 Units. As a result, the total number of Ford Stock Units held by the reporting person also was similarly overstated in the two subsequent Form 4s filed by the reporting person.
