- (3) Since the date of grant, the common stock of the Company split in two separate 2-for-1 stock splits on December 31, 2004 and June 30, 2006, resulting in the reporting person receiving an additional 1,620 Retention Units. The current aggregate amount of Retention Units for this grant is 2,160.
