The number of share equivalents shown is an estimate because the Reporting Person's interest in the Plan is denominated in units.

Represents a payout of phantom stock units under the Plan pursuant to an election made by the Reporting Person in 2008. Each phantom stock unit represents a hypothetical investment in Hanesbrands Inc. common stock under the Plan. On January 22, 2010, 1,222 of the

(2) Reporting Person's phantom stock units were settled for cash. The dollar amount being distributed to the Reporting Person was determined by multiplying the number of share equivalents being distributed to the Reporting Person by \$24.11 (the closing price for Hanesbrands Inc. common stock on the valuation date of December 31, 2009).

(3) The balance is determined by dividing the value in the Reporting Person's account following the reported transaction by \$22.88 (the closing price for Hanesbrands Inc. common stock on the transaction date of January 22, 2010).
