- (1) The Reporting Person receives one share of Common Stock for each restricted stock unit that vests.  
In accordance with the issuer's equity award program, restricted stock units were forfeited to issuer in satisfaction of tax withholding obligation upon vesting of 4,300 restricted stock units on April 8, 2010. The issuer returned such forfeited restricted stock units to the respective stock plan.
- (3) Shares of Common Stock acquired under the Corporation's Stock Incentive Plan, which is a grant of Restricted Stock. The 9,500 shares granted 4/12/2010 vest 25% yearly commencing 4/8/2011.
- (4) This grant has a FMV of \$21.835.
- (5) Total direct holdings include shares held in the Dividend Reinvestment Plan, shares acquired through the Employee Stock Purchase Plan and shares acquired pursuant to Restricted Stock Awards and Restricted Stock Unit distributions.
