- The reported transaction involves an award of restricted stock units under the M&T Bank Corporation 2009 Equity Incentive Compensation Plan. Each restricted stock unit represents a contingent right to receive one share of M&T Bank Corporation common stock upon vesting.
- (1) The restricted stock unit award includes a total of 5,113 shares. 511 shares of the restricted stock unit award will vest on January 31, 2014; an additional 1,022 shares will vest on January 30, 2015; an additional 1,534 shares will vest on January 29, 2016; and the remaining 2,046 shares will vest on January 31, 2017.
 - (2) The restricted stock units were granted under an equity incentive compensation plan maintained by M&T Bank Corporation, and therefore the reporting person paid no price for the restricted stock units.
 - (3) The restricted stock unit award includes a total of 3,097 shares. 929 shares of the restricted stock unit award will vest on January 30, 2015; an additional 929 shares will vest on January 29, 2016; and the remaining 1,239 shares will vest on January 31, 2017. This restricted stock unit award is intended to meet the requirements of the TARP Interim Final Rule's definition of "long-term restricted stock" as the award relates to the reporting person's performance during the period of time in 2012 that M&T continued to have an

outstanding TARP obligation.
