These shares will vest annually at a rate of 33% beginning on September 23, 2014, if the Reporting Person continues to be employed by the Issuer or any of its subsidiaries on each annual vesting date, pursuant to the terms of an Employment Agreement, entered into as of August 23, 2013, between the Reporting Person and Spirit AeroSystems, Inc., the Issuer's wholly-owned subsidiary.
- (2) Restricted stock award. These shares will vest annually at a rate of 25% beginning on September 23, 2014, if the Reporting Person continues to be employed by the Issuer or any of its subsidiaries on each annual vesting date, pursuant to the terms of an Employment Agreement, entered into as of August 23, 2013, between the Reporting Person and Spirit AeroSystems, Inc., the Issuer's wholly-owned subsidiary.
