(2) acquired in transactions exempt under Rule 16b-3, including 6.28 units acquired since the date of the reporting person's last ownership report. On the transaction date, Dow liquidated the Olin Stock Fund, and replaced the investment with an investment unrelated to Olin. Conversion price is the per share price reported by Dow for plan level transactions in the CEOP.
