(1) Restricted stock units ("RSUs") convert into common stock on a one-for-one basis.

In connection with the vesting of shares of RSUs pursuant to the Frank's International N.V. 2013 Long-Term Incentive Plan, Frank's International N.V. (the "Issuer") withheld vested shares to satisfy tax withholding obligations. The number of vested shares withheld was based on the closing price per share on April 30, 2018. The withholding of vested shares pursuant to this award was approved by the Board of Supervisory Directors of the Issuer, and the number of shares indicated in this Form 4 was acquired as treasury stock by the Issuer.

(3) On May 19, 2017, the reporting person was granted 18,204 RSUs, which vested in full on May 1, 2018.

(4) Consists of 166,773 RSUs that will vest ratably in three equal annual installments beginning on September 26, 2018 and 86,600 RSUs that will vest ratably in three annual installments beginning on February 19, 2019.
