The Reporting Person was granted 5,619 shares of Restricted Common Stock under the 2013 Stock-Based Incentive Compensation Plan. 1,921 time-vested restricted shares vest over a three year period as follows: 640 time-vested restricted shares on May 14, 2017, 640 (1) time-vested restricted shares on January 8, 2018 and 641 time-vested restricted shares on January 8, 2019. The final 3,698 performance-based restricted shares vest on January 8, 2019 based on the Company's Total Shareholder Return versus a defined peer group of companies, with the final number of performance-based vested shares varying from 0 to 200% of 3,698.
