- (3) Shares withheld to cover required tax withholding on vesting of restricted stock - data provided by plan administrator on 06/05/07.

- (4) With tandem tax withholding right

- (5) Exercisable ratably over four years, beginning 12/17/2003.

- (6) One share of Apache common stock for each restricted stock unit.
