## GOL Launches New Destination: João Pessoa in Northeast Brazil

**São Paulo, January 14, 2005** GOL Linhas Aéreas Inteligentes S.A. (NYSE: GOL and Bovespa: GOLL4), Brazil's low-fare, low-cost airline, today announced that it will launch a weekly flight to João Pessoa on January 15. The new flight will allow the Company to serve major cities in Northeast Brazil, a significant commercial region. The commencement of the new flight coincides with GOL's fourth anniversary of operations.

The new flight will be offered on Saturdays and will connect João Pessoa and São Paulo (Congonhas airport), both ways, with a stopover at Rio de Janeiro (Galeão airport). In the cities of São Paulo and Rio de Janeiro, passengers may choose a connecting flight to one of 38 destinations in Brazil and one abroad, in addition to 300 daily flights. With additional flight service to Paraíba's beautiful beaches, we anticipate increased tourism growth in the region, says Tarcísio Gargioni, GOL's Marketing and Services Vice-President.

The Northeast represents 13 percent of the Brazilian Gross National Product (GNP) and accounts for a 70 percent increase in international tourism to this region since 2001, a factor that has contributed to the success of the Company's operations. The start of operations at João Pessoa demonstrates GOL's confidence in the economic potential of the Northeast region, stated Mr. Gargioni.
