Pursuant to the writ of summons and notice served on May 11, 2005 (i) on Brasil Telecom S.A. ( BT or Company ) (ii) on Brasil Telecom Participações S.A., and (iii) on 14 Brasil Telecom Celular S.A., the Company's Board of Directors Meeting set for this date, at 4:30 p.m. has not been held, in compliance with the decision rendered on May 10, 2005, in the provisional remedy N. 2005.001.053977 -1, filed by *Investidores Institucionais Fundo de Investimento em Ações* (Institutional Investors Equities Investment Mutual Fund) against Verônica Valente Dantas and others, among which BT, in course before the 8<sup>th</sup> Corporate Court of Rio de Janeiro, which granted a preliminary order prohibiting *"the opening and holding of the mentioned Prior Meeting of Invitel's shareholders called for May 11, 2005, as well as of the mentioned Board of Directors Meetings of Brasil Telecom Participações S.A. and of Brasil Telecom S.A. called for May 12, 2005"*. Accordingly, BT's Board of Directors Chairman, which was present at the place and time set for the holding of the aforementioned Board of Directors Meeting, draws up the present certification of the non-holding of the conclave.
