**Sao Paulo, April 27, 2007** GOL Linhas Aereas Inteligentes (NYSE: GOL and Bovespa: GOLL4), Brazil's low-cost, low-fare airline, published today 2006 Corporate Responsibility Report. In 2006, GOL invested almost R\$ 4 million in corporate responsibility programs across Brazil, including organizations benefiting education, culture, sports, health and sanitation. Additionally, the Company invested in programs or projects related to environmental conservation.

Some of the organizations GOL supported in 2006 include: Apae, SOS Mata Atlântica, AACD, Instituto Ashoka, Fundação Gol de Letra, Canto Cidadão, Projeto Felicidade, Care Brasil, Eu Quero Ajudar, Expedicionários da Saúde, Pastoral da Criança, Centro Infantil Boldrini, Expedição Vaga Lume, Instituto da Família, Futebol dos Atores and Instituto Criar de TV e Cinema.
