- (2) This grant was for 450,000 performance-vesting restricted stock units, each representing the right to receive one share of the Company's common stock, one-fifth of which will vest on each of March 14, 2013, 2014, 2015, 2016 and 2017, in each case if the Company's non-GAAP earnings per share for the prior year is greater than or equal to the objective established by the Company's Board of Directors for the year, all as set forth in further detail in Mr. Durkin's employment agreement with the Company.
- (3) One-fourth of these options vest on each of March 14, 2014, 2015, 2016 and 2017.
