- The award criteria for these performance restricted stock units ("PRSUs") was met on May 29, 2018. On June 5, 2018, the Compensation and Leadership Development Committee of the Board of Directors of PROS Holdings, Inc. ("Company") approved the vesting of such shares to be issued.
- (1) and Leadership Development Committee of the Board of Directors of PROS Holdings, Inc. ("Company") approved the vesting of such shares to be issued.
 - (2) One share of the Company's common stock was issued for each performance share that vested.
 - (3) This is the second tranche of this PRSU award, granted on September 9, 2016 in the total amount of 200,000 PRSUs under the Company's 2007 Equity Incentive Plan. This grant is eligible for vesting based on the average trailing closing price per share of the Company's common stock meeting certain minimum performance hurdles for at least 105 calendar days prior to September 9, 2020, with 25% vesting at \$27, 25% vesting at \$33, and the remaining 50% vesting at \$41.
 - (4) Includes PRSUs that were granted on September 9, 2016 in the total amount of 200,000 PRSUs under the Company's 2007 Equity Incentive Plan. The remainder are eligible to vest in one tranche if the performance hurdle is met prior to September 9, 2020.
