- (1) Represents an award of restricted stock units pursuant to Rule 16b-3(d) of Section 16b of the Securities Exchange Act of 1934.
- (2) Between May 16, 2017 and February 13, 2018, the Reporting Person acquired 256 shares of DRE common stock through dividend reinvestment.
- (3) Pursuant to a previous election under the Directors' Deferred Compensation Plan of Duke Realty Corporation, upon the vesting of restricted stock units, the Reporting Person deferred the receipt of 5,242 shares of common stock and instead received 5,242 shares of phantom stock.
