These divisions generally function separately from each other with respect to investment research activities and they make investment decisions and proxy voting decisions for the investment companies on a separate basis.

Shares reported by Capital World Investors, include 179,610 shares resulting from the assumed conversion of \$21,170.00 principal amount of the 3.7% Convertible Senior Note due 01/15/2027 and 45,890 shares resulting from the assumed conversion of \$1,900.00 principal amount of the 8.0% Convertible Senior Note due 04/15/2009.
