Item 1. Security and Issuer

This Schedule 13D relates to the Common Stock of Siberian Energy Group Inc. (the "Company"). The principal executive offices of the Company are located at 275 Madison Ave, 6th Floor, New York, NY 10016.

Item 2. Identity and Background

(a)-(c) This Statement on Schedule 13D is being filed by David Zaikin, an individual, and the Chief Executive Officer and Director of the Company.

(d)-(e) During the last five years, Mr. Zaikin: (i) has not been convicted in a criminal proceeding (excluding traffic violations or similar misdemeanors); or (ii) was not a party to a civil proceeding of a judicial or administrative body of competent jurisdiction and as a result of such proceeding was or is subject to a judgment, decree or final order enjoining future violations of, or prohibiting or mandating activities subject to, federal or state securities laws or finding any violation with respect to such laws.

(f) Mr. Zaikin is a citizen of Canada.

Item 3. Source of Amount of Funds or Other Compensation

Mr. Zaikin received his shares and options over the course of the past five years in consideration for services rendered to the Company and in consideration for the forgiveness of debt owned to Mr. Zaikin by the Company. WCM Ltd. received its 400,000 shares in connection with and in consideration for the Company's 2003 purchase of its then wholly-owned subsidiary Zauralneftegaz Ltd.

Item 4. Purpose of Transaction

Mr. Zaikin acquired the securities for investment purposes. Depending on general market and economic conditions affecting the Company and other relevant factors, Mr. Zaikin may purchase additional securities of the Company or dispose of some or all of the securities from time to time in open market transactions, private transactions or otherwise.

Mr. Zaikin also acquired the securities of the Company in a transaction which may relate to or result in:

- (a) the acquisition by persons of additional securities of the Company, or the disposition of securities of the Company;
- (b) a reorganization involving the Company;
- (c) a sale or transfer of a material amount of assets of the Company or any of its subsidiaries;
- (d) a change in the present board of directors and management of the Company, including plans or proposals to change the number or term of directors or to fill any existing vacancies on the board;
- (e) a material change in the present capitalization or dividend policy of the Company;
- (f) other material changes in the Company's business or corporate structure;

changes in the Company's charter, bylaws or instruments corresponding thereto or other actions which may impede the acquisition of control of the Company by any person;

Mr. Zaikin does not have any immediate plans or proposals which relate to or result in:

- (h) causing a class of securities of the Company to be delisted from a national securities exchange or cease to be authorized to be quoted in an inter-dealer quotation system of a registered national securities association;

- (j) any action similar to any of those enumerated in (h) through (i), above.

Item 5. Interest in Securities of the Issuer

- (a) Mr. Zaikin beneficially owns 1,160,000 shares of common stock (which includes 400,000 shares which he beneficially owns through control of WCM, Ltd.) and options to purchase an aggregate of 600,000 shares of the Company's common stock representing 6.2% of the Company's currently outstanding shares and 9.1% of the Company's outstanding shares assuming the exercise of all options held by Mr. Zaikin, based on the 18,705,585 shares of the Company's common stock outstanding as of the date of this report.
- (b) Mr. Zaikin holds the rights to vote 1,160,000 shares of common stock (which includes 400,000 shares which he beneficially owns through control of WCM, Ltd.) representing 6.2% of the Company's total voting shares.
- (c) N/A.
- (d) No other person has the right to receive or the power to direct the receipt of dividends from or the proceeds from the sale of the 1,160,000 shares of common stock or the 600,000 options beneficially owned by Mr. Zaikin.
