On April 9, 2012, the reporting person elected to redeem 503 shares of vested phantom stock previously granted under ARMOUR Residential REIT, Inc.'s 2009 Stock Incentive Compensation Plan into 503 shares of ARMOUR's common stock, and received 652 shares of ARMOUR common stock pursuant to quarterly compensation paid for the reporting person's service on ARMOUR's Board of
