- (2) convert into one share of Cardtronics common stock as follows: 50% of the units on January 31, 2016; 25% of the units on January 31, 2017; and 25% of the units on January 31, 2018.
- (3) This number, less today's grant, represents Restricted Stock Units previously granted to the owner pursuant to Cardtronics' 2011, 2012 and 2013 Long Term Incentive Plans with the same conversion formula, i.e. 50% two years after grant date and 25% in each of years 3 and 4 following the grant date.
