(1) Each restricted stock unit represents a contingent right to receive one share of PolyOne common stock.

(2) SARs become exercisable and vest only upon the achievement of both price and time requirements. To vest, each one-third of the grant must attain 10%, 15% and 20% stock appreciation, respectively (which must be maintained for a minimum of thirty consecutive trading days) from the grant date closing price of \$38.27 per share and no more than one-third of the grant can vest per year during the first three years.
