(1) Restricted stock units convert into common stock on a one-for-one basis.

On December 15, 2017, the reporting person had 122 shares withheld and cancelled to cover minimum required tax withholdings due to the vesting of restricted stock units. These share cancellations are shown on Table I as dispositions (Transaction Code "D" in Column 4), although none of these cancelled shares were sold into the market, as indicated by Transaction Code "F" in Column 3.

(2) On December 17, 2017, the reporting person had 186 shares withheld and cancelled to cover minimum required tax withholdings due to the vesting of restricted stock units. These share cancellations are shown on Table I as dispositions (Transaction Code "D" in Column 4), although none of these cancelled shares were sold into the market, as indicated by Transaction Code "F" in Column 3.

(3) The NFG stock fund under the NFG 401(k) plan is denominated in units, representing ownership interests in a fund that includes both NFG common stock and a reserve of cash. The information reported represents the dollar value of the reporting person's balance in the NFG stock fund as of December 15, 2017, as reported by the plan administrator, divided by the closing price of NFG common stock on that date.

(4) The NFG employee stock ownership plan is denominated in units, representing ownership interests in a fund that includes both NFG common stock and a reserve of cash. The information reported represents the dollar value of the reporting person's balance in the ESOP as of December 15, 2017, as reported by the plan administrator, divided by the closing price of NFG common stock on that date.

(5) On December 15, 2016, the reporting person was granted 984 restricted stock units, vesting as follows: 328 on December 15, 2017, 328 on December 15, 2018, and 328 on December 15, 2019.

(6) On December 17, 2015, the reporting person was granted 1,509 restricted stock units, vesting as follows: 503 on December 17, 2016, 503 on December 17, 2017, and 503 on December 17, 2018.
