(1) Mosing Holdings, LLC made a distribution of shares of Frank's International N.V.'s common stock, par value Euro 0.01 per share (the "Common Stock") to certain of its members, including Kirkland D. Mosing.

(2) Kirkland D. Mosing Family, L.L.C. ("KDM LLC") directly owns 13,224,888 shares of Frank's International N.V.'s common stock, par value Euro 0.01 per share. KDM LLC is controlled by Kirkland D. Mosing, in his capacity as its sole manager.

(3) As a result of the Voting Agreement, dated July 22, 2013, by and among Ginsoma Family C.V., FWW B.V., Mosing Holdings, LLC and the other parties thereto, Mr. Mosing may be deemed to beneficially own shares of Common Stock owned by Mosing Holdings, LLC. Mr. Mosing disclaims beneficial ownership of the Common Stock owned by Mosing Holdings, LLC, except to the extent of his pecuniary interest therein.

(4) The Reporting Person's original Form 4 incorrectly stated that the relationship of the Reporting Person to the Issuer was only that of a 10% owner. The Reporting Person is also a member of the Board of Directors of the Issuer. No other changes have been made in connection with this amendment.
