- (1) The reporting person was issued an equity award of 6,954 restricted stock units on November 6, 2015 in consideration of services performed for the Issuer in fiscal 2015.  
The restricted stock units represent the contingent right to receive an equivalent number of shares of the Issuer's Class A Common Stock and are subject to the following vesting schedule: (i) 50% of the stock units are fully vested; and (ii) 50% of the stock units will vest in three equal annual installments beginning on November 6, 2016.
- (3) The reporting person was issued an equity award of 6,954 restricted stock units on November 6, 2015 in consideration of services performed for the Issuer in fiscal 2016.
- (4) The restricted stock units represent the contingent right to receive an equivalent number of shares of the Issuer's Class A Common Stock and will vest in four equal annual installments beginning on November 6, 2016.
